April 12, 2018) (argued) (reversing and vacating adverse Arizona Court of Appeals memorandum decision, affirming trial court's decision to vacate \$667,000 default judgment, and clarifying meritorious defense standard applicable to default judgments under Ariz.R.Civ.P. 60(c)(6)).
- Wilshire Insurance Company v. Alvardo, et al., 2008 WL 7935047 (Ariz.Super.) (Trial Order) (won declaratory relief action on intentional act exclusion on behalf of Wilshire Insurance. Court found it is appropriate to declare that the insurance policy in question does not cover the acts that were contemplated by Defendant in this matter)
